VENDING AGREEMENT

This agreement is entered into this _____ day of _____, 2023 by and between The Maryland Jockey Club of Baltimore City, Inc. ("Pimlico") and _____ ("Vendor").

For and in Consideration of the mutual promises contained in this agreement, the parties, intending to be legally bound, agree as follows:

- 1) On Black-Eyed Susan Day, Friday, May 19, 2023; and Preakness Day, Saturday May 20, 2023, commencing at eight o'clock a.m., Pimlico will provide Vendor with:
 - A) One admission pass and a Black-Eyed Susan & Preakness Day credential for Vendor's exclusive use and the same for one Vendor's assistant, if Vendor brings an assistant. Credential photo must be submitted when requested.
 - B) One parking pass.
 - C) One 8-foot-long display table and two chairs.
 - D) A prominent display location, selected by Pimlico, in the Pimlico Grandstand for the purpose of selling Vendor's inventory; subject to change, at the discretion of Pimlico management.
- 2) Delivery and setup by Vendor may commence at eight o'clock a.m. on each of the two dates outlined in 1) above.
- 3) Vendor shall follow all directives of Pimlico officials.
- 4) Vendor shall deliver to Pimlico Vending Fee payment and deliver to Troy Burton or Cathy Bouck, Maryland Jockey Club, P.O. Box 130, Route 198 and Racetrack Road, Laurel, MD 20725, by **Friday, May 5, 2023**.
- 5) Written notice addressed as follows to one party is deemed received by that party at the time of mailing:

Vendor hereby waives the Statute of Limitations as to all lawsuits or causes of action filed by Pimlico to collect unpaid Vending Fees under this agreement.

Vendor hereby waives formal service of process in lawsuits and causes of action to collect unpaid Vending Fees. Vendor consents to accept service of process at Vendor's address identified in 5) a) delivered by; United States Mail, general delivery; or by physical posting a copy of the process to an entrance door at the address.

- 6) Vendor shall be responsible for securing Vendor's property. Pimlico shall not be liable to Vendor for loss or damage to Vendor's inventory unless the damage is caused by the negligence of a Pimlico Employee.
- 7) **CREDIT CARD PAYMENT:** If you have elected to pay for the Service by credit card, and the Maryland Jockey Club does not receive payment from the credit card issuer, you agree to pay all amounts due to the Maryland Jockey Club immediately upon demand by the Maryland Jockey Club. Each time you use the Service, you agree that the Maryland Jockey Club is authorized to charge your designated credit card account (or other means of payment) for the applicable rate for the Service then in effect. Please note that your agreement with your credit card issuer or bank governs your use of your credit card, and you must refer to that agreement to ascertain your rights and liabilities as a cardholder.
